CERTIFICATE OF WATER RIGHT

THIS CERTIFICATE ISSUED TO

CROOKED RIVER CENTRAL DITCH COMPANY RURAL ROUTE 1, BOX 10 REDMOND, OREGON 97756

AND

USA, BUREAU OF RECLAMATION ACTING THROUGH THE REGIONAL DIRECTOR 1150 NORTH CURTIS ROAD BOISE, IDAHO 83706-1234

confirms the right to use the waters of PRINEVILLE RESERVOIR, CONSTRUCTED UNDER PERMIT R-2223, AND THE CROOKED RIVER, tributaries of the DESCHUTES RIVER, for IRRIGATING 69.5 ACRES AND SUPPLEMENTAL IRRIGATION OF 169.7 ACRES.

This right was perfected under Permit 25991. The date of priority is APRIL 8, 1914. This right is limited to 5.98 CUBIC FEET PER SECOND or its equivalent in case of rotation, measured at the points of diversion from the source.

The points of diversion are located as follows:

- #1 BOWMAN DAM SW¼ NW¼, SECTION 11, T 17 S, R 16 E, W.M.; 1650 FEET SOUTH AND 300 FEET EAST FROM THE NW CORNER OF SECTION 11.
- #2 PEOPLES DITCH COMPANY CANAL NW $\frac{1}{4}$ SW $\frac{1}{4}$, SECTION 8, T 15 S, R 16 E, W.M.; 730 FEET SOUTH AND 330 FEET EAST FROM THE WEST $\frac{1}{4}$ CORNER OF SECTION 8.
- #3 CROOKED RIVER CENTRAL DITCH COMPANY CANAL NW¼ NE¼, SECTION 27, T 14 S, R 15 E, W.M.; 80 FEET SOUTH AND 1240 FEET EAST FROM THE NORTH ¼ CORNER OF SECTION 27.

Additional points of diversion are located as follows:

- #4 DIRECT DIVERSION #43 NE¹/₄ NE¹/₄, SECTION 19, T 14 S, R 15 E, W.M.; 1050 FEET SOUTH AND 30 FEET WEST FROM THE NE CORNER OF SECTION 19.
- #5 DIRECT DIVERSION #45 SE¼ NW¼, SECTION 19, T 14 S, R 15 E, W.M.; 970 FEET NORTH AND 1730 FEET EAST FROM THE WEST ¼ CORNER OF SECTION 19.

The amount of water used for irrigation together with the amount secured under any other right existing for the same lands, is limited to a diversion of ONE-FORTIETH of one cubic foot per second (or its equivalent) and 4.0 acre-feet for each acre irrigated during the irrigation season of each year from direct flow and storage from the reservoir constructed under permit R-2223.

The use shall conform to such reasonable rotation system as may be ordered by the proper state officer.
