CERTIFICATE OF WATER RIGHT

THIS CERTIFICATE ISSUED TO

confirms the right to use the waters of WELL 2 in the TUALATIN RIVER BASIN for INDUSTRIAL USE.

This right was perfected under Permit G-2485. The date of priority is JUNE 25, 1963. The amount of water to which this right is entitled is limited to an amount actually beneficially used and shall not exceed 0.10 CUBIC FOOT PER SECOND IF AVAILABLE AT OLD WELL LOCATED AT 1315 FEET SOUTH AND 70 FEET WEST FROM THE NORTHEAST CORNER OF SECTION 29, BEING WITHIN THE NE $\frac{1}{4}$  NE $\frac{1}{4}$  OF SECTION 29, T 1 S, R 1 W, W.M., measured at the well.

The well is located as follows:

LOT 1 (SW $\frac{1}{4}$  NE $\frac{1}{4}$ ), SECTION 33, T 1 S, R 2 W, W.M.; 850 FEET SOUTH AND 700 FEET WEST FROM THE SW CORNER OF DLC 54.

The use shall conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use to which this right is appurtenant is as follows:

LOT 1 (SW $\frac{1}{4}$  NE $\frac{1}{4}$ )  
SECTION 33  
TOWNSHIP 1 SOUTH, RANGE 2 WEST, W.M.

The well shall be maintained in accordance with the General Standards for the Construction and Maintenance of Water Wells in Oregon.

The use of water shall be in conformance with the requirements of the Cooper Mountain-Bull Mountain Critical Ground Water Area Order.

This certificate describes that portion of the water right confirmed by Certificate 67374, State Record of Water Right Certificates, NOT modified by the provisions of an order of the Water Resources Director entered OCT 9 1996, approving Transfer Application 7365

The issuance of this superseding certificate does not confirm the status of the water right in regard to the provisions of ORS 540.610 pertaining to forfeiture or abandonment.

The right to the use of the water for the above purpose is restricted to beneficial use on the lands or place of use described.
