CERTIFICATE OF WATER RIGHT

THIS CERTIFICATE ISSUED TO

W.A. OWEN HAINES, OREGON 97833

confirms the right to use the waters of ROCK CREEK, a tributary of the POWDER RIVER, for IRRIGATION of 160.0 ACRES.

This right was confirmed by decree of the Circuit Court of the State of Oregon for BAKER County. The decree is of record at Salem, in the Order Record of the WATER RESOURCES DIRECTOR, in Volume 6, at Page 291. The dates of priority are 1884 for Tract 1 and 1882 for Tract 2.

The amount of water to which this right is entitled is limited to an amount actually beneficially used and shall not exceed 1/40th of one cubic foot per second per acre, or its equivalent in case of rotation, measured at the point of diversion from the source.

The points of diversion are located as follows:

Tract 1: Owen-Cartmill Ditch.

Tract 2: Anderson Morris Ditch in the SW¼ NW¼, SECTION 36, T 7 S, R 38 E, WM; 797 FEET NORTH AND 377 FEET WEST FROM THE SE CORNER OF THE SW¼ NW¼, SECTION 36;

Owen Ditch in the SE% NE%, SECTION 34, T 7 S, R 38 E, WM; 463 FEET NORTH AND 594 FEET WEST FROM THE E% CORNER, SECTION 34.

A description of the place of use to which this right is appurtenant is as follows:
