CERTIFICATE OF WATER RIGHT

THIS CERTIFICATE ISSUED TO

CARNEY LANSFORD RT. 1, BOX 66 BAKER CITY, OR 97814

confirms the right to use the waters of SALMON CREEK, a tributary of POWDER RIVER, for SUPPLEMENTAL IRRIGATION OF 89.4 ACRES.

This right was perfected under Permit 47837. The date of priority is JUNE 6, 1983. The amount of water to which this right is entitled is limited to an amount actually beneficially used and shall not exceed 2.24 CUBIC FEET PER SECOND, or its equivalent in case of rotation, measured at the point of diversion from the source.

The points of diversion are located as follows:

SE 1/4 SE 1/4, SECTION 5, T 9 S, R 39 E, W.M.; 530 FEET NORTH AND 850 FEET WEST FROM THE SE CORNER OF SECTION 5.

LOT 8 (NE 1/4 SW 1/4), SECTION 8, T 9 S, R 39 E, W.M.; 2700 FEET SOUTH AND 1320 FEET EAST FROM THE NW CORNER OF SECTION 8.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, is limited to ONE-FORTIETH of one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed 3.5 acrefeet per acre for each acre irrigated during the irrigation season of each year. The right shall be limited to any deficiency in the available supply of any prior right for the same land and shall not exceed the limitation allowed herein.

The use shall conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use to which this right is appurtenant is as follows:
