CERTIFICATE OF WATER RIGHT

THIS CERTIFICATE ISSUED TO

WARD AGRICULTURAL PROPERTIES 1500 H STREET BAKER CITY, OR 97814

confirms the right to use the waters of THREE WELLS in the POWDER BASIN for IRRIGATION AND SUPPLEMENTAL IRRIGATION.

This right was perfected under Permit U-165. The date of priority is JUNE 23, 1945. This right is limited to 7.176 CUBIC FEET PER SECOND, BEING 2.00 CFS EACH FROM WELLS NOS. 1 AND 2 AND 1.58 CFS EACH FROM WELL NOS. 4 AND 6, or its equivalent in case of rotation, measured at the well.

The wells are located as follows:

WELL NO. 1: SE¼ NW¼, WELL NO. 2: SW¼ NE¼, WELL NO. 6: NE¼ NE¼, SECTION 7, TOWNSHIP 9 SOUTH, RANGE 40 EAST, W.M., WELL NO. 4: SW¼ SW¼ SECTION 9 TOWNSHIP 9 SOUTH, RANGE 40 EAST, W.M.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, is limited to a diversion of ONE-FORTIETH of one cubic foot per second (or its equivalent) for each acre irrigated during the irrigation season of each year.

The use shall conform to such reasonable rotation system as may be ordered by the proper state officer.
