CERTIFICATE OF WATER RIGHT

THIS CERTIFICATE ISSUED TO

WILLIAM R. PEYRON
SPARTA STAGE
BAKER CITY, OREGON 97814

confirms the right to use the waters of POWDER RIVER, a tributary of SNAKE RIVER for IRRIGATION of 418.1 acres of land.

This right was perfected under Permit 32989. The date of priority is SEPTEMBER 5, 1967. This right is limited to 10.45 CUBIC FEET PER SECOND or its equivalent in case of rotation, measured at the point of diversion from the source.

The point of diversion is located as follows:

CORRELL DITCH - 50 FEET NORTH AND 2720 FEET EAST FROM THE CENTER OF SECTION 8; SW $\frac{1}{4}$ NW $\frac{1}{4}$, SECTION 9, T 9 S, R 40 E, W.M.

SMITH DITCH - 6150 FEET SOUTH AND 1920 FEET WEST FROM THE NE CORNER OF SECTION 18; NW $\frac{1}{4}$ NE $\frac{1}{4}$, SECTION 19, T 10 S, R 40 E, W.M.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, is limited to a diversion of ONE-FORTIETH of one cubic foot per second or its equivalent and 3.5 acre-feet for each acre irrigated during the irrigation season of each year.

The use shall conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use to which this right is appurtenant is as follows:
