CERTIFICATE OF WATER RIGHT

THIS CERTIFICATE ISSUED TO

J. P. ATWOOD
BAKER, OREGON 97814

confirms the right to use the waters of SUTTON CREEK, a tributary of POWDER RIVER and POWDER RIVER, a tributary of SNAKE RIVER for STOCK, SUB-IRRIGATION AND IRRIGATION.

This right was confirmed by decree of the Circuit Court of the State of Oregon for BAKER County. The decree is of record at Salem, in the Order Record of the WATER RESOURCES DIRECTOR, in Volume 6, at Page 291. The date of priority is FEBRUARY 1893 FOR STOCK, 1908 FOR SUB-IRRIGATION OF 5 ACRES, 1904 FOR IRRIGATION OF 16.8 ACRES, AND 1908 FOR IRRIGATION OF 22.29 ACRES.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, is limited to a diversion of ONE-FORTIETH of one cubic foot per second for each acre irrigated during the irrigation season of each year.

A description of the place of use to which this right is appurtenant is as follows:

This certificate describes that portion of the water right confirmed by Certificate 3980 State Record of Water Right Certificates, NOT modified by the provisions of an order of the Water Resources Director entered on FEB 25 1997 and recorded in Special Order Volume 51, page 148 approving a petition by the Baker Valley Irrigation District under ORS 541.329.


The issuance of this superseding certificate does not confirm the status of the water right in reference to ORS 540.610 pertaining to forfeiture
