CERTIFICATE OF WATER RIGHT

THIS CERTIFICATE ISSUED TO

CHANDLER HEREFORDS, INC.
ROUTE 1 BOX 190
BAKER CITY, OREGON 97814

confirms the right to use the waters of NELSON SLOUGH, a tributary of POWDER RIVER, for IRRIGATION of 202.4 acres and SUPPLEMENTAL IRRIGATION of 176.0 acres.

This right was perfected under Permit 36323. The date of priority is June 30, 1971 for 6.4 cubic feet per second and August 10, 1971 for 2.1 cubic feet per second. This right is limited to 8.5 CUBIC FEET PER SECOND or its equivalent in case of rotation, measured at the point of diversion from the source.

The point of diversion is located as follows:

SW $\frac{1}{4}$ SW $\frac{1}{4}$, SECTION 24, TOWNSHIP 8 SOUTH, RANGE 39 EAST, W.M., 10 FEET NORTH AND 1340 FEET EAST FROM SW CORNER, SECTION 24.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, is limited to a diversion of ONE-FORTIETH of one cubic foot per second (or its equivalent) and 3.5 acre-feet for each acre irrigated during the irrigation season of each year.

The use shall conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use to which this right is appurtenant is as follows:

Certificate 4236 State Record of Water Right Certificates, NOT modified by the provisions of an order of the Water Resources Department entered on FEB 25 1997 and recorded in Special Order Volume 51, page 148 Approving a petition by the Baker Valley Irrigation District under ORS 541.329.

The issuance of this superceding certificate does not confirm the status of the water right in reference to ORS 540.610 pertaining to forfeiture or abandonment.

The right to the use of the water for the above purpose is restricted to beneficial use on the lands or place of use described and is subject to all other conditions and limitations contained in said permit.
