CERTIFICATE OF WATER RIGHT

THIS CERTIFICATE ISSUED TO

W.B. WILLOUGHBY NEW BRIDGE, OREGON

confirms the right to use the waters of EAGLE CREEK, a tributary of POWDER RIVER for IRRIGATION OF 34.0 ACRES.

This right was confirmed by decree of the Circuit Court of the State of Oregon for Baker County. The decree is of record at Salem, in the Order Record of the WATER RESOURCES DIRECTOR, in Volume 6, at Page 291. The date of priority is 1887 FOR TRACT 1 AND 1885 FOR TRACT 2.

The use is limited to 0.85 CUBIC FOOT PER SECOND or it's equivalent in case of rotation.

The point of diversion is located as follows:

TRACT 1 - MOODY DITCH - 2130 FEET NORTH AND 650 FEET EAST FROM THE SW CORNER OF SECTION 3, T 9 S, RANGE 45 EAST, W.M.

TRACT 2 - NEWT YOUNG DITCH - 1950 FEET SOUTH AND 1400 FEET EAST FROM THE NW CORNTER OF SECTION 33, T 8 S, R 45 E, W.M.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, is limited to a diversion of ONE-FORTIETH of one cubic foot per second for each acre irrigated during the irrigation season of each year.
