CERTIFICATE OF WATER RIGHT

confirms the right to use the waters of A WELL in the HARBOR BASIN for the purpose of IRRIGATING 10.4 ACRES.

The right has been perfected under Permit G-10573. The date of priority is DECEMBER 16, 1985. The amount of water to which this right is entitled is limited to an amount actually beneficially used and shall not exceed 0.13 CUBIC FOOT PER SECOND, or its equivalent in case of rotation, measured at the point of diversion from the source.

The well is located as follows:

NW 1/4 SE 1/4, AS PROJECTED WITHIN DLC 42, SECTION 9, T 41 S, R 13 W, W.M.; 1330 FEET NORTH AND 2260 FEET WEST FROM THE SE CORNER OF SECTION 9.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to ONE-EIGHTIETH of one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed 2.5 acre-feet per acre for each acre irrigated during the irrigation season of each year, PROVIDED THE TOTAL APPROPRIATION FOR THIS RIGHT SHALL NOT EXCEED 13.72 ACRE-FEET.

The use shall conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use under the right, and to which such right is appurtenant, is as follows:

NW 1/4 SE 1/4 10.4 ACRES  
AS PROJECTED WITHIN DLC 42  
SECTION 9  
TOWNSHIP 41 SOUTH, RANGE 13 WEST, W.M.

THIS WATER RIGHT IS TO BRING THE AUTHORIZED USE OF WATER TO THE FULL DUTY ALLOWED BY THE HARBOR GROUND WATER RESERVOIR DECREE OF THE CIRCUIT COURT OF THE STATE OF OREGON FOR CURRY COUNTY. THIS WATER RIGHT IS USED TOGETHER WITH THE WATER RIGHT DESCRIBED BY CERTIFICATE 49751.

The user shall maintain a weir, meter or other suitable measuring device and shall keep a complete record of the amount of ground water withdrawn.


The well shall be maintained in accordance with the General Standards for the Construction and Maintenance of Water Wells in Oregon.
