CERTIFICATE OF WATER RIGHT

confirms the right to use the waters of A WELL in the CROOKED RIVER BASIN for IRRIGATION OF 26.0 ACRES.

This right was perfected under Permit G-11301. The date of priority is FEBRUARY 20, 1991. The amount of water to which this right is entitled is limited to an amount actually beneficially used and shall not exceed 72 GALLONS PER MINUTE, or its equivalent in case of rotation, measured at the point of diversion from the source.

The well is located as follows:

NE 1/4 NW 1/4, SECTION 15, T 15 S, R 16 E, W.M., 490 FEET SOUTH AND 171 FEET WEST FROM THE N 1/4 CORNER OF SECTION 15.

The amount of water used for irrigation together with the amount secured under any other right existing for the same lands, is limited to a diversion of ONE-EIGHTIETH of one cubic foot per second (or its equivalent) and 3.0 acre-feet for each acre irrigated during the irrigation season of each year.

The use shall conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use to which this right is appurtenant is as follows:

NW 1/4 NE 1/4 14.4 ACRES
SW 1/4 NE 1/4 2.8 ACRES
NE 1/4 NW 1/4 8.8 ACRES
SECTION 15
TOWNSHIP 15 SOUTH, RANGE 16 EAST, W.M.

When required by the department, the user shall install and maintain a weir, meter or other suitable measuring device and shall keep a complete record of the amount of ground water withdrawn.

The use of water shall be limited when it interferes with the prior SURFACE OR GROUND WATER rights of others.

The Director may require water level or pump test results every ten years.

The well shall be maintained in accordance with the General Standards for the Construction and Maintenance of Water Wells in Oregon.

Failure to comply with any of the provisions of this right may result in action including, but not limited to restrictions on the use, civil penalties, or cancellation of the right.
