CERTIFICATE OF WATER RIGHT

THIS CERTIFICATE ISSUED TO

STEVEN W. CASEBEER ROUTE 1, BOX 810 BONANZA, OR 97623

confirms the right to use the waters of LOST RIVER, a tributary of TULE LAKE, for IRRIGATING 34.0 ACRES.

This right was confirmed by decree of the Circuit Court of the State of Oregon for KLAMATH COUNTY. The decree is of record at Salem, in the Order Record of the WATER RESOURCES DIRECTOR, in Volume 5, at Page 4782. The date of priority is 1902.

The amount of water to which this right is entitled is limited to an amount actually beneficially used and shall not exceed 0.42 CUBIC FOOT PER SECOND WHEN AVAILABLE AT THE ORIGINAL POINT OF DIVERSION: SE 1/4 NE 1/4, SECTION 17, T 39 S, R 11 E, W.M.; SOUTH 31 DEGREES 02 MINUTES, EAST 2754.4 FEET FROM THE N 1/4 CORNER OF SECTION 17, or its equivalent in case of rotation, measured at the point of diversion from the source.

The point of diversion is located as follows:

SE 1/4 NW 1/4, SECTION 16, T 39 S, R 11 E, W.M.; 2960 FEET NORTH AND 1340 FEET EAST FROM THE SW CORNER OF SECTION 16.

A description of the place of use to which this right is appurtenant is as follows:

SW 1/4 NW 1/4 34.0 ACRES SECTION 16 TOWNSHIP 39 SOUTH, RANGE 11 EAST, W.M.

When in the judgment of the Watermaster it becomes necessary to install headgates and measuring devices:

the diversion works shall include an in-line flow meter, a weir, or other suitable device for measuring the water to which the wateruser is entitled;

the type and plans of the measuring device be approved by the Watermaster before the beginning of construction work and that the weir or measuring device be installed under the general supervision of said Watermaster.

This certificate is issued to confirm a change in POINT OF DIVERSION approved by an order of the Water Resources Director entered MARCH 11, 1976, and together with Certificate 43601, supersedes Certificate 4782, State Record of Water Right Certificates.

The issuance of this superseding certificate does not confirm the status of the water right in regard to the provisions of ORS 540.610 pertaining to forfeiture or abandonment.
