RESERVOIRS  
for LIVESTOCK, WILDLIFE AND FIRE PROTECTION.

The right to store and use these waters was perfected under Reservoir Application R-76878.  
The date of priority is January 1, 1993. The amount of water entitled to be stored and  
used each year under this right is not more than 0.083 ACRE-FOOT, BEING  
0.013 AF IN RES 1, 0.010 AF IN RES 2, 0.011 AF IN RES 3, 0.005 AF  
IN RES 4, 0.007 AF IN RES 5, 0.008 AF IN RES 6, 0.006 AF IN RES 7,  
0.008 AF IN RES 8, 0.006 AF IN RES 9 AND 0.009 AF IN RES 10
