confirms the right to use the waters of COLUMBIA RIVER, a tributary of PACIFIC OCEAN, for IRRIGATION OF 3200.0 ACRES.

This right was perfected under Permit 37833. The date of priority is FEBRUARY 26, 1975. The amount of water to which this right is entitled is limited to an amount actually beneficially used and shall not exceed 42.6 CUBIC FEET PER SECOND, or its equivalent in case of rotation, measured at the point of diversion from the source.

The point of diversion is located as follows:

SW 1/4 NW 1/4, SECTION 8, T 5 N, R 30 E, W.M.; 2910 FEET NORTH AND 120 FEET EAST FROM THE SW CORNER OF SECTION 8.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, is limited to ONE-FORTIETH of one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed 4.5 ACRE-FEET per acre for each acre irrigated during the irrigation season of each year.

The use shall conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use to which this right is appurtenant is as follows:

The right to the use of the water for the above purpose is restricted to beneficial use on the lands or place of use described. The use confirmed herein may be made only at times when sufficient water is available to satisfy all prior rights, including rights for maintaining instream flows.
