CERTIFICATE OF WATER RIGHT

THIS CERTIFICATE ISSUED TO

FRED P. MCCLINTICK

confirms the right to use the waters of SUCKER CREEK, a tributary of the ILLINOIS RIVER, for IRRIGATION OF 10.0 ACRES.

This right was confirmed by decree of the Circuit Court of the State of Oregon for JOSEPHINE County. The decree is of record at Salem, in the Order Record of the WATER RESOURCES DIRECTOR, in Volume 5, at Page 398. The date of priority is 1908.

The amount of water to which this right is entitled is limited to an amount actually beneficially used and shall not exceed 0.11 CUBIC FOOT PER SECOND or its equivalent in case of rotation, measured at the point of diversion from the source, and that the use of water for irrigation purposes shall be confined to the season April 1 through October 31 of each year.

The point of diversion is located as follows:

NW 1/4 SE 1/4, SECTION 29, T 39 S, R 7 W, W.M.; 1600 FEET NORTH AND 1650 FEET WEST FROM THE SE CORNER OF SECTION 29.

A description of the place of use to which this right is appurtenant is as follows:

The right to the use of the water for the above purpose is restricted to beneficial use on the lands or place of use described and is subject to all other conditions and limitations contained in said decree.

This certificate is issued to confirm a change in PLACE OF USE approved by an order of the Water Resources Director entered MAY 9, 1980, and together with Certificate 49706, supersedes Certificate 7153, State Record of Water Right Certificates.

The issuance of this superseding certificate does not confirm the status of the water right in regard to the provisions of ORS 540.610 pertaining to forfeiture or abandonment.
