## CERTIFICATE OF WATER RIGHT

THIS CERTIFICATE ISSUED TO

HIROSHI WALTER EMORI AND HIROMU MORIKONE 7717 UPPER APPLEGATE ROAD JACKSONVILLE, OREGON 97530

confirms the right to use the waters of the APPLEGATE RIVER, a tributary of the ROGUE RIVER, for the purpose of IRRIGATING 15.0 ACRES.

The right has been confirmed by decree of the Circuit Court of the State of Oregon for JACKSON County. The decree is of record at Salem, in the Order Record of the WATER RESOURCES DIRECTOR, in Volume 4, at page 22. The date of priority is 1876.

The amount of water to which this right is entitled is limited to an amount actually beneficially used and shall not exceed 0.37 CUBIC FOOT PER SECOND, or its equivalent in case of rotation, measured at the point of diversion from the source, IF AVAILABLE AT THE ORIGINAL POINT OF DIVERSION.

The point of diversion is located as follows:

SE 1/4 SW 1/4, SECTION 28, T 39 S, R 3 W, W.M.; 10 FEET NORTH AND 370 FEET WEST FROM THE SOUTH 1/4 CORNER OF SECTION 28.

A description of the place of use under the right, and to which such right is appurtenant, is as follows:

SE 1/4 SW 1/4 15.0 ACRES SECTION 28 TOWNSHIP 39 SOUTH, RANGE 3 WEST, W.M.

When in the judgment of the Watermaster it becomes necessary to install headgates and measuring devices:

the diversion works shall include an in-line flow meter, a weir, or other suitable device for measuring the water to which the wateruser is entitled;

the type and plans of the measuring device be approved by the Watermaster before the beginning of construction work and that the weir or measuring device be installed under the general supervision of said Watermaster.

This certificate is issued to confirm a change in POINT OF DIVERSION approved by an order of the Water Resources Director entered AUGUST 1, 1980, and together with Certificate 49689, supersedes Certificate 38778, State Record of Water Right Certificates.

The issuance of this superseding certificate does not confirm the status of the water right in regard to the provisions of ORS 540.610 pertaining to forfeiture or abandonment.
