CERTIFICATE OF WATER RIGHT

THIS CERTIFICATE ISSUED TO

DOUGLAS R STANDFORD RT 1 BOX 66A NORTH POWDER, OR 97867

confirms the right to use the waters of North Powder River, a tributary of POWDER RIVER for IRRIGATION of 114.0 acres.

This right was confirmed by decree of the Circuit Court of the State of Oregon for UNION County. The North Powder River Decree is of record at Salem, in the Order Record of the WATER RESOURCES DIRECTOR, in Volume 3, at Page 252. The date of priority is 1899.

The amount of water entitled and hereby confirmed for the purposes aforesaid is limited to an amount actually beneficially used and shall not exceed 2.85 CUBIC FEET PER SECOND from March 1st to July 1st and 1.42 CUBIC FEET PER SECOND from July 1st to October 1st or its equivalent in case of rotation. This right is further limited to a total diversion not to exceed $2\frac{1}{2}$ acre feet for each acre irrigated, or 285 acre feet, during the irrigation season of each year.

The points of diversion are located as follows:

Div. Pt.1 - Smith McPhee and Tanner Ditch: NW1/4 SW1/4, Section 32, Township 6 South, Range 39 East, W.M.; 1410 feet North and 570 feet East from the Southwest corner of Section 32.

Div. Pt.2 - McPhee Ditch: NW1/4 NW1/4, Section 33, Township 6 South, Range 39 East, W.M; 910 feet South and 340 feet East from NW corner Section 33.

A description of the place of use to which this right is appurtenant is as follows:
