CERTIFICATE OF WATER RIGHT

THIS CERTIFICATE ISSUED TO

PHILLIPS-INGLE DITCH IMPROVEMENT DISTRICT

confirms the right to use the waters of GOOSE CREEK AND WEST EAGLE CREEK, tributaries of POWDER RIVER for SUPPLEMENTAL IRRIGATION of **454.0** acres; being **21.0** acres for TRACT 1 and **433.0** acres for TRACT 2.

This right was perfected under Permits 11042 for TRACT 1 and 11045 for TRACT 2. The dates of priority are October 4, 1933 for TRACT 1 and October 30, 1933 for TRACT 2.

The use is limited to **5.67** CUBIC FEET PER SECOND or its equivalent in case of rotation, measured at the point of diversion from the sources; being 0.26 cfs for TRACT 1 and 5.41 cfs for TRACT 2.

The water diverted for TRACT 1 shall be from Goose Creek until May 20 to June 1, and then from West Eagle Creek for the rest of the irrigation season.

The water diverted for TRACT 2 may be diverted from West Eagle Creek when insufficient water is available for appropriation in Goose Creek.

The points of diversion are located as follows:

Phillips & Ingle Ditch from West Eagle Creek:

SE $\frac{1}{4}$  SE $\frac{1}{4}$ , Section 8, Township 6 South, Range 43 East W.M.; 1249 feet north and 477 feet west from the SE corner of said Sec. 8.

Phillips & Ingle Ditch from Goose Creek:

NE $\frac{1}{4}$  SE $\frac{1}{4}$ , Section 4, Township 8 South, Range 43 East W.M.; 1703 feet north and 482 feet west from the SE corner of said Sec. 4.

Phillips & Ingle #2 Ditch from Goose Creek:

SW $\frac{1}{4}$  SW, Section 20, Township 8 South, Range 43 East W.M.; 1175 feet north and 3985 feet west from the SE corner of said Sec. 20.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, is limited to a diversion of ONE-FORTIETH of one cubic foot per second for each acre irrigated during the irrigation season of each year and shall not exceed 3 acre feet per acre throughout the irrigation season of April 1 to October 1.

The use shall conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use to which this right is appurtenant is as follows:
