CERTIFICATE OF WATER RIGHT

THIS CERTIFICATE ISSUED TO

JOHN AND EVA RICHARDS
1831 WEST EVANS CREEK ROAD
ROGUE RIVER, OREGON 97537

confirms the right to use the waters of EVANS CREEK, a tributary of the ROGUE RIVER, for the purpose of IRRIGATING 8.6 ACRES.

The right has been confirmed by SUPPLEMENTAL DECREE of the Circuit Court of the State of Oregon for JACKSON County. The SUPPLEMENTAL DECREE is of record at Salem, in the Order Record of the WATER RESOURCES DIRECTOR, in Volume 13, at page 386. The date of priority is 1902.

The amount of water to which this right is entitled is limited to an amount actually beneficially used and shall not exceed 0.15 CUBIC FOOT PER SECOND IF AVAILABLE AT THE ORIGINAL POINT OF DIVERSION, or its equivalent in case of rotation, measured at the point of diversion from the source

The point of diversion is located as follows:

NE 1/4 NE 1/4, SECTION 9, T 36 S, R 4 W, W.M.; 1110 FEET SOUTH AND 550 FEET WEST FROM THE NE CORNER OF SECTION 9.

A description of the place of use under the right, and to which such right is appurtenant, is as follows:

NE 1/4 NE 1/4	4.8 ACRES
NW 1/4 NE 1/4	1.5 ACRES
SW 1/4 NE 1/4	1.4 ACRES
SE 1/4 NE 1/4	0.9 ACRE

ALL LYING BELOW THE OLD MILL DITCH
SECTION 9
TOWNSHIP 36 SOUTH, RANGE 4 WEST, W.M.

All of which are in that part of the following-described land: Commencing at the section corner common to Sections 3, 4, 9, and 10, T 36 S, R 4 W, W.M., Jackson County, Oregon; thence South 0 degrees 25 minutes East along the section line common to Sections 9 and 10, 776.16 feet; thence South 75 degrees 30 minutes West 462.0 feet to the true point of beginning; thence running South 24 degrees 57 minutes East 602.2 feet; thence South 0 degrees 25 minutes East 248.6 feet; thence East 198.0 feet to the section line; thence South 0 degrees 25 minutes East along said section line 162.0 feet (to a point from which the quarter section corner common to Sections 9 and 10 bears South 0 degrees 25 minutes East 793.3 feet); thence South 75 degrees 30 minutes West 7,960 feet; thence North 10 degrees 0 minutes West 207.5 feet; thence South 76 degrees 0 minutes West 1,893 feet, more or less, to the North and South center line of Section 9; thence North along said center line 841.0 feet; thence North 75 degrees 30 minutes East 2,265.0 feet, more or less, to the point of beginning.

The right to the use of the water for the above purpose is restricted to beneficial use on the lands or place of use described and is subject to all other conditions and limitations contained in said decree.

This certificate is issued to confirm a change in POINT OF DIVERSION approved by an order of the Water Resources Director entered NOVEMBER 18, 1983, and together with Certificate 51981, supersedes Certificate 32799, State Record of Water Right Certificates.

The issuance of this superseding certificate does not confirm the status of the water right in regard to the provisions of ORS 540.610 pertaining to forfeiture or abandonment.

When in the judgment of the Watermaster it becomes necessary to install headgates and measuring devices:

the diversion works shall include an in-line flow meter, a weir, or other suitable device for measuring the water to which the wateruser is entitled;

the type and plans of the measuring device be approved by the Watermaster before the beginning of construction work and that the weir or measuring device be installed under the general supervision of said Watermaster.

The quantity of water diverted at the new point of diversion, together with that diverted at the old diversion, shall not exceed the quantity of water available at the original point of diversion.
