CERTIFICATE OF WATER RIGHT

THIS CERTIFICATE ISSUED TO

SKYLINE FARMS, INCORPORATED ONTARIO, OREGON 97914

confirms the right to use the waters of the MALHEUR RIVER, a tributary of the SNAKE RIVER, for IRRIGATION OF 89.4 ACRES.

This right was perfected under Permit 33946. The date of priority is OCTOBER 25, 1968. The amount of water to which this right is entitled is limited to an amount actually beneficially used and shall not exceed 2.24 CUBIC FOOT PER SECOND or its equivalent in case of rotation, measured at the point of diversion from the source.

The point of diversion is located as follows:

NE% NE%, SECTION 10, T 18 S, R 46 E, WM; 510 FEET SOUTH AND 600 FEET WEST FROM THE NE CORNER, SECTION 10.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, is limited to ONE-FORTIETH of one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed 3.0 acre-feet for each acre irrigated during the irrigation season of each year.

The use shall conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use to which this right is appurtenant is as follows:

NE¼ SW¼ 25.2 ACRES NW¼ SE¼ 15.4 ACRES SECTION 26 LOT 1 (NE% NE%) 13.2 ACRES LOT 2 (NW% NE%) 1.1 ACRES SECTION 5

SECTION 5 TOWNSHIP 18 SOUTH, RANGE 46 EAST, W.M.

SW% SE% 22.4 ACRES SECTION 32 TOWNSHIP 17 SOUTH, RANGE 46 EAST, W.M.

This certificate describes that portion of the water right confirmed by Certificate 40574, State Record of Water Right Certificates, NOT modified by the provisions of an order of the Water Resources Director entered $\frac{\text{FEB } 25 \text{ 1997}}{\text{FEB } 25 \text{ 1997}}$, approving Transfer Application 7623.

The issuance of this superseding certificate does not confirm the status of the water right in regard to the provisions of ORS 540.610 pertaining to forfeiture or abandonment.
