CERTIFICATE OF WATER RIGHT

THIS CERTIFICATE ISSUED TO

SKYLINE FARMS, INCORPORATED
ONTARIO, OREGON 97914

confirms the right to use the waters of the SNAKE RIVER, a tributary of the COLUMBIA RIVER, for IRRIGATION OF 186.8 ACRES.

This right was perfected under Permit 33944. The date of priority is OCTOBER 25, 1968. The amount of water to which this right is entitled is limited to an amount actually beneficially used and shall not exceed 4.67 CUBIC FOOT PER SECOND or its equivalent in case of rotation, measured at the point of diversion from the source.

The point of diversion is located as follows:

LOT 1 (NE¼ NW¼), SECTION 21, T 17 S, R 47 E, WM; 350 FEET SOUTH AND 1980 FEET EAST FROM THE NW CORNER, SECTION 21.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, is limited to ONE-FORTIETH of one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed 4.0 acre-feet for each acre irrigated during the irrigation season of each year.

The use shall conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use to which this right is appurtenant is as follows:
