CERTIFICATE OF WATER RIGHT

THIS CERTIFICATE ISSUED TO

ROCK CREEK DISTRICT IMPROVEMENT COMPANY
PO BOX 28
WAMIC, OR 97063

confirms the right to use the waters of THREEMILE CREEK, a tributary of WHITE RIVER, for IRRIGATION.

This right was perfected under Permit 5879. The date of priority is MAY 12, 1923. The amount of water to which this right is entitled is limited to an amount actually beneficially used and shall not exceed 1.86 CUBIC FEET PER SECOND, or its equivalent in case of rotation, measured at the point of diversion from the source.

The point of diversion is located as follows:

NE 1/4 NE 1/4, SECTION 10, T 4 S, R 11 E, W.M.; 726 FEET SOUTH AND 528 FEET WEST FROM THE NE CORNER OF SECTION 10.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, is limited to ONE-EIGHTIETH of one cubic foot per second per acre, or its equivalent for each acre irrigated.

The use shall conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use to which this right is appurtenant is as follows:

This certificate is issued to confirm a change in PLACE OF USE approved by an order of the Water Resources Director entered JANUARY 5, 1981, and supersedes Certificate 8413, State Record of Water Right Certificates.

The issuance of this superseding certificate does not confirm the status of the water right in regard to the provisions of ORS 540.610 pertaining to forfeiture or abandonment.
