CERTIFICATE OF WATER RIGHT

confirms the right to use the waters of POWDER RIVER, TRIBUTARY OF SNAKE RIVER, INCLUDING WATER STORED IN THIEF VALLEY RESERVOIR, constructed under Permit R-667, a tributary of POWDER RIVER, for IRRIGATION (IR) OF 531.9 ACRES, SUPPLEMENTAL IRRIGATION (IS) OF 6582.0 ACRES, AND WILDLIFE ATTRACTION (W) FOR 10.1 ACRES.

This right was perfected under Permit 11092. The date of priority is NOVEMBER 4, 1933. The amount of water to which this right is entitled is limited to an amount actually beneficially used and shall not exceed a total of 13.36 CUBIC FEET PER SECOND, being 0.11 cubic feet per second for diversion 1; 5.01 cubic feet per second for diversion 2; 0.28 cubic feet per second for diversion 3; 0.0 cubic feet per second for diversion 4; 3.72 cubic feet per second for diversion 5; and not to exceed 4.24 cubic feet per second from a combination of diversion 6 and diversion 8; or its equivalent in case of rotation, measured at the point of diversion from direct flow, and storage allowed under Permit R-667.

The points of diversion are located as follows:

- 1 -- EMELE DITCH - NE $\frac{1}{4}$  SE  $\frac{1}{4}$ , SECTION 20, Township 7 South, Range 41 East, WM., 450 feet South and 250 feet West from the East quarter corner of said section.
- 2 -- BASCHE DITCH - NW $\frac{1}{4}$  SE  $\frac{1}{4}$ , SECTION 28, Township 7 South, Range 41 East, WM., 1880 feet North and 600 feet East from the South quarter corner of said section.
- 3 -- DUNCAN DITCH - SE $\frac{1}{4}$  NW $\frac{1}{4}$ , SECTION 34, Township 7 South, Range 41 East, WM., 1050 feet North and 2420 feet East from the West quarter corner of said section.
- 4 -- ERWIN DITCH - SE $\frac{1}{4}$  NW $\frac{1}{4}$ , SECTION 34, Township 7 South, Range 41 East, WM., 3850 feet North and 100 feet West from the South quarter corner of said section.
- 5 -- CRANSTON DITCH - SW $\frac{1}{4}$  NW $\frac{1}{4}$ , SECTION 17, Township 8 South, Range 42 East, WM., 880 feet East of the West quarter corner of said section.
- 6 -- PERKINS DITCH - NW $\frac{1}{4}$  SW $\frac{1}{4}$ , SECTION 17, Township 8 South, Range 42 East, WM., 50 feet South and 800 feet East from the West quarter corner of said section.
- 8 -- (old) PERKINS DITCH - NE $\frac{1}{4}$  NE $\frac{1}{4}$ , SECTION 18, Township 8 South, Range 42 East, WM., 900 feet South and 700 feet West from the NE corner of said section.
- 9 -- THIEF VALLEY RESERVOIR OUTLET - NE $\frac{1}{4}$  SW $\frac{1}{4}$ , SECTION 26, Township 6 South, Range 40 East, W.M., 2122 feet North and 1893 feet East from the southwest corner of said section.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, is limited to ONE-FORTIETH of one cubic foot per second per acre, from direct flow, or its equivalent for each acre irrigated during the irrigation season from April 1 to October 1 of each year.

The use shall conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use to which this right is appurtenant is as follows:
