CERTIFICATE OF WATER RIGHT

THIS CERTIFICATE ISSUED TO

STAN WEISHAAR
65001 OREGON HWY 237
LA GRANDE, OR 97850

confirms the right to use the waters of GRANDE RONDE RIVER, a tributary of SNAKE RIVER, for IRRIGATION OF 52.8 ACRES.

This right was perfected under Permit 28804. The date of priority is DECEMBER 17, 1962. The amount of water to which this right is entitled is limited to an amount actually beneficially used and shall not exceed 1.32 CUBIC FEET PER SECOND or its equivalent in case of rotation, measured at the point of diversion from the source.

The point of diversion is located as follows:

SE $\frac{1}{4}$ NW $\frac{1}{4}$, SECTION 32, TOWNSHIP 2 SOUTH, RANGE 39 EAST, W.M.;
560 FEET NORTH AND 60 FEET WEST FROM THE CENTER, SECTION 32.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, is limited to ONE-FORTIETH of one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed 3.0 acre-feet for each acre irrigated during the irrigation season of each year; provided further that the right to use of water is limited to the period when the flow of the Lower Grande Ronde River is more than 300 c.f.s. at USGS Gage No. 3325, and more than 420 c.f.s. at Ore-Wash border.

The use shall conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use to which this right is appurtenant is as follows:

SW $\frac{1}{4}$ NW $\frac{1}{4}$ 29.4 ACRES
SECTION 5
SE $\frac{1}{4}$ NE $\frac{1}{4}$ 23.4 ACRES
SECTION 6
TOWNSHIP 3 SOUTH, RANGE 39 EAST, W.M.

This certificate describes that portion of the water right confirmed by Certificate 34638, State Record of Water Right Certificates, NOT modified by the provisions of an order of the Water Resources Director entered MAR 10 1997, approving Transfer Application 6760.

The issuance of this superseding certificate does not confirm the status of the water right in regard to the provisions of ORS 540.610 pertaining to forfeiture or abandonment.

The right to the use of the water for the above purpose is restricted to beneficial use on the lands or place of use described. The use confirmed herein may be made only at times when sufficient water is maintaining instream flows.
