CERTIFICATE OF WATER RIGHT

THIS CERTIFICATE ISSUED TO

DOUGLAS R STANDFORD  
RT 1 BOX 66A  
NORTH POWDER, OR 97867

confirms the right to use the waters of WELL NUMBER 1 AND WELL NUMBER 2 in the NORTH POWDER BASIN for SUPPLEMENTAL IRRIGATION of 432.9 ACRES.

This right was perfected under Permit G-2662. The date of priority is MAY 20, 1964. The amount of water to which this right is entitled is limited to an amount actually beneficially used and shall not exceed 5.3 CUBIC FEET PER SECOND or its equivalent in case of rotation, measured at the well.

The well is located as follows:

Well # 1- 660 feet South and 10 feet East from the North $\frac{1}{4}$  Corner of Section 33, Township 6 South, Range 39 East, W.M.; being within the NW  $\frac{1}{4}$  of the NE  $\frac{1}{4}$  of Section 33.

Well # 2, 1260 feet South and 1650 feet East from the North $\frac{1}{4}$  Corner of Section 33, Township 6 South, Range 39 East, W.M.; being within the NE  $\frac{1}{4}$  of the NE  $\frac{1}{4}$  of Section 33.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, is limited to a diversion of ONE-EIGHTIETH of one cubic foot per second, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed 3.0 acre-feet per acre for each acre irrigated during the irrigation season of each year.

The use shall conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use to which this right is appurtenant is as follows:

The well shall be maintained in accordance with the General Standards for the Construction and Maintenance of Water Wells in Oregon.

This certificate describes that portion of the water right confirmed by Certificate 35203, State Record of Water Right Certificates, NOT modified by the provisions of an order of the Water Resources Director entered APR 10 1997, approving a co-petition by Douglas R. Stanford under ORS 541.327 for mapping water rights within a district. .

The issuance of this superseding certificate does not confirm the status of the water right in regard to the provisions of ORS 540.610 pertaining to forfeiture or abandonment.

The right to the use of the water for the above purpose is restricted to beneficial use on the lands or place of use described.
