CERTIFICATE OF WATER RIGHT

THIS CERTIFICATE ISSUED TO

VALE OREGON IRRIGATION DISTRICT 521 "A" STREET WEST VALE, OREGON 97918

confirms the right to use the waters of WILLOW CREEK, a tributary of MALHEUR RIVER for IRRIGATION OF 165.0 ACRES, AND STOCK.

This right was confirmed by decree of the Circuit Court of the State of Oregon for Malheur County. The decree is of record at Salem, in the Order Record of the WATER RESOURCES DIRECTOR, in Volume 3, at Page 258. The date of priority is 1882 for Tract 1, and 1908 for Tract 2.

The use is limited to 3.14 CUBIC FEET PER SECOND (Tract 1) and 1.0 CUBIC FOOT PER SECOND (Tract 2) from February 15th to May 1st and 1.57 CUBIC FEET PER SECOND (Tract 1) and 0.5 CUBIC FOOT PER SECOND (Tract 2) from May 1st to September 1st, if available at J. L. Pope Ditch, or the equivalent in case of rotation. The total quantity diverted during each irrigation season shall not exceed 495.0 ACRE FEET.

The points of diversion are located as follows:

J. L. Pope Ditch - SE% NW%, Section 5, Township 17 South, Range 44 East., W.M.

LATERAL 417 - SE% NE%, Section 31, Township 16 South, Range 44 East., W.M.; 2430 feet South and 28 feet West from the NE Corner of Section 31.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, is limited to a diversion of ONE-FORTIETH of one cubic foot per second from February 15th to May 1st and ONE-EIGHTIETH of one cubic foot per second from May 1st to September 1st, or the equivalent for each acre irrigated during the irrigation season of each year.
