## CERTIFICATE OF WATER RIGHT

THIS CERTIFICATE ISSUED TO

VALE OREGON IRRIGATION DISTRICT 521 "A" STREET WEST VALE, OREGON 97918

confirms the right to use the waters of WILLOW CREEK, a tributary of MALHEUR RIVER for SUPPLEMENTAL IRRIGATION OF 144.0 ACRES.

This right was confirmed by decree of the Circuit Court of the State of Oregon for Malheur County. The decree is of record at Salem, in the Order Record of the WATER RESOURCES DIRECTOR, in Volume 3, at Page 258. The date of priority is 1882.

The amount of water to which this right is entitled, is limited to an amount actually beneficially used for said purposes, and shall not exceed a total of 3.6 CUBIC FEET PER SECOND from February 15th to May 1st and 1.8 CUBIC FEET PER SECOND from May 1st to September 1st, if available at the point of diversion located in the SE% NE%, Section 23, Township 16 South, Range 43 East, W.M., or the equivalent in case of rotation. The total quantity diverted during each irrigation season shall not exceed 432.0 ACRE FEET.

The points of diversion are located as follows:

LATERAL 397 - SW% NW%, Section 24, Township 16 South, Range 43 East, W.M.; 2730 feet North and 152 feet East from the SW corner of Section 24.

CHAMBERLAIN PUMP - SE% SW% Section 32, Township 16 South, Range 44 East, W.M.; 2062 feet East from the SW corner of Section 32.

The amount of water used for supplemental irrigation, together with the amount secured under any other right existing for the same lands, is limited to a diversion of ONE-FORTIETH of one cubic foot per second from February 15th to May 1st and ONE-EIGHTIETH of one cubic foot per second from May 1st to September 1st, or the equivalent for each acre irrigated during the irrigation season of each year.

A description of the place of use to which this right is appurtenant is as follows:

The amount of water used for supplemental irrigation, is limited to any deficiency in the available supply of any primary right existing for the same lands.

This certificate confirms an order of the director entered on November 4, 20002, and recorded in Special Order Volume 56, Page 2004, approving a petition by Vale Oregon Irrigation District Under ORS 541.329 for mapping water rights within a district and an order of the director approving Transfer 7887 entered on September 7, 1999, and recorded at Special Order Volume 53, Page 1208. This certificate supersedes Certificate 1608.

The right to the use of the water for the above purposes is restricted to beneficial use on the lands or place of use described and is subject to all other conditions and limitations contained in said decree.
