CERTIFICATE OF WATER RIGHT

THIS CERTIFICATE ISSUED TO

VALE OREGON IRRIGATION DISTRICT  
521 "A" STREET WEST  
VALE, OREGON 97918

confirms the right to use the waters of WILLOW CREEK, a tributary of MALHEUR RIVER for IRRIGATION OF 344.8 ACRES and STOCK.

This right was confirmed by decree of the Circuit Court of the State of Oregon for Malheur County. The decree is of record at Salem, in the Order Record of the WATER RESOURCES DIRECTOR, in Volume 3, at Page 258. The dates of priority are 1871 for Tract 1 and 1873 for Tract 2.

The amount of water to which this right is entitled, is limited to an amount actually beneficially used for said purposes, and shall not exceed a total of 8.62 CUBIC FOOT PER SECOND from February 15th to May 1st and 4.31 CUBIC FEET PER SECOND from May 1st to September 1st, if available at the authorized point of diversion, or the equivalent in case of rotation. The total quantity diverted during each irrigation season shall not exceed 1,034.4 ACRE FEET.

The point of diversion is located as follows:

LATERAL 385 - SE $\frac{1}{4}$  SW $\frac{1}{4}$ , Section 10, Township 16 South, Range 43 East, W.M.; 840 feet North and 180 feet West from the South  $\frac{1}{4}$  Corner of Section 10.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, is limited to a diversion of ONE-FORTIETH of one cubic foot per second from February 15th to May 1st and ONE-EIGHTIETH of one cubic foot per second from May 1st to September 1st, or an equivalent for each acre irrigated during the irrigation season of each year.

A description of the place of use to which this right is appurtenant is as follows:
