CERTIFICATE OF WATER RIGHT

THIS CERTIFICATE ISSUED TO

VALE OREGON IRRIGATION DISTRICT
521 "A" STREET WEST
VALE, OREGON 97918

confirms the right to use the waters of WILLOW CREEK, a tributary of MALHEUR RIVER for SUPPLEMENTAL IRRIGATION OF 90.0 ACRES and STOCK.

This right was confirmed by decree of the Circuit Court of the State of Oregon for Malheur County. The decree is of record at Salem, in the Order Record of the WATER RESOURCES DIRECTOR, in Volume 3, at Page 258. The date of priority is 1904.

The amount of water to which this right is entitled, is limited to an amount actually beneficially used for said purposes, and shall not exceed 0.23 CUBIC FEET PER SECOND from February 15th to September 1st, if available at Lateral 385 - SE $\frac{1}{4}$ SW $\frac{1}{4}$, Section 10, Township 16 South, Range 43 East, W.M.; 840 feet North and 180 feet West from the South $\frac{1}{4}$ Corner of Section 10, or the equivalent in case of rotation.

The point of diversion is located as follows:

LATERAL 444 & 445 - NE $\frac{1}{4}$ SE $\frac{1}{4}$, Section 15, Township 17 South, Range 44 East, W. M.; 2058 feet North and 1169 feet West from the SE Corner of Section 15.

The amount of water used for supplemental irrigation, together with the amount secured under any other right existing for the same lands, is limited to a diversion of ONE-FORTIETH of one cubic foot per second from February 15th to May 1st and ONE-EIGHTIETH of one cubic foot per second from May 1st to September 1st, or the equivalent, for each acre irrigated during the irrigation season of each year.

A description of the place of use to which this right is appurtenant is as follows:


The amount of water used for supplemental irrigation, is limited to any deficiency in the available supply of any primary right existing for the same lands.

This certificate confirms an order of the director entered on November 4, 2002, and recorded in Special Order Volume 56, Page 2004, approving a petition by Vale Oregon Irrigation District Under ORS 541.329 for mapping water rights within a district. This certificate supersedes Certificate 1575.

The right to the use of the water for the above purposes is restricted to beneficial use on the lands or place of use described and is subject to all other conditions and limitations contained in said decree.
