	of record in the Record of Proceedings of said Board, at Salem, in Volume 1
	nt page 168 , on the 18th day of November, 1914 ; that the priority of
	the right hereby confirmed dates from April 23, 1910 ; that the amount of
	water to which such right is entitled and hereby confirmed, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not
hereund	exceed 0.04 cubic feet per second or its equivalent in case of rotation. The er shall conform to any reasonable rotation system ordered by the proper state of all description of the lands under such right, and to which the water hereby confirmed is appurtenant, or, if for other purposes, the place where such water is put to beneficial use, is as follows:
	Three (3) acres in the NW $\frac{1}{4}$ of SW $\frac{1}{4}$ ; Section Ten (10), Township Thirty (30) South Range Four (4) West of Willamette Meridian.
