confirms the right to use the waters of ONE (1) WELL [THE SOURCE OF WATER GRANTED HEREIN INCLUDES EFFLUENT FROM THE HOG RAISING OPERATION] in the UMATILLA RIVER BASIN for IRRIGATION OF 266.7 ACRES.

This right was perfected under Permit G-2672. The date of priority is JUNE 5, 1964. The amount of water to which this right is entitled is limited to an amount actually beneficially used and shall not exceed 3.33 CUBIC FEET PER SECOND, or its equivalent in case of rotation, measured at the point of diversion from the source.

The well is located as follows:

WELL 1: NE 1/4 SE 1/4, SECTION 27, T 4 N, R 27 E, W.M.; BEING 1420 FEET NORTH AND 490 FEET WEST FROM THE SE CORNER OF SECTION 27.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, is limited to ONE-EIGHTIETH of one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed 3.0 acrefeet per acre for each acre irrigated during the irrigation season of each year; PROVIDED FURTHER THAT THE RIGHT TO THE USE OF THE EFFLUENT FROM HOG RAISING FOR IRRIGATION IS EXEMPT FROM THOSE LIMITS AND CONTINUES THROUGHOUT THE YEAR AS REQUIRED FOR DISPOSAL PURPOSES. SUCH WATERS WILL BE IMPOUNDED AT TIMES IN THE SEWER LAGOONS TO PROVIDE TEMPORARY SYSTEM STORAGE.

The use shall conform to such reasonable rotation system as may be ordered by the proper state officer.
