CERTIFICATE OF WATER RIGHT

THIS CERTIFICATE ISSUED TO

DAMASCUS WATER DISTRICT
19750 SE DAMASCUS LANE
BORING, OREGON 97009

confirms the right to use the waters of ONE WELL in the RICHARDSON BRANCH BASIN for QUASI-MUNICIPAL.

This right was perfected under Permit G-8493. The date of priority is MARCH 1, 1979, FOR 0.56 CUBIC FOOT PER SECOND; AND APRIL 6, 1979, FOR 0.55 CFS. This right is limited to 1.11 CUBIC FEET PER SECOND or its equivalent in case of rotation, measured at the well.

The well is located as follows:

SW 1/4 NE 1/4, SECTION 9, T 2 S, R 3 E, W.M.; BEING 1825 FEET SOUTH AND 1560 FEET WEST FROM THE NE CORNER OF SECTION 9.

The use shall conform to such reasonable rotation system as may be ordered by the proper state officer.

TOWNSHIP 2 SOUTH, RANGE 3 EAST, W.M.

This use may be regulated if analysis of data available discloses that the appropriation will measurably reduce the surface water flows necessary to maintain the free-flowing character of a scenic waterway in quantities necessary for recreation, fish and wildlife in effect as of the priority date of this right or as those quantities may be subsequently reduced.

The user shall install and maintain a weir, meter or other suitable measuring device and shall keep a complete record of the amount of ground water withdrawn.

The well shall be maintained in accordance with the General Standards for the Construction and Maintenance of Water Wells in Oregon.

The use of water allowed herein may be made only at times when sufficient water is available to satisfy all prior rights, including rights for maintaining instream flows.

The right to use water for the above purpose is restricted to beneficial use on the lands or place of use described.
