CERTIFICATE OF WATER RIGHT

THIS CERTIFICATE ISSUED TO

LARRY K. & BARBARA J. SHARPF
3730 TURNBRIDGE WELLS
SALEM, OREGON 97302

confirms the right to use the waters of A WELL in the SQUAW CREEK BASIN for IRRIGATING 9.0 ACRES.

This right was perfected under Permit G-7092. The date of priority is DECEMBER 26, 1976. The amount of water to which this right is entitled is limited to an amount actually beneficially used and shall not exceed 0.11 CUBIC FOOT PER SECOND, or its equivalent in case of rotation, measured at the well.

The well is located as follows:

NE $\frac{1}{4}$ SE $\frac{1}{4}$, SECTION 26, T.15 S., R. 10 E., W.M.; 2750 FEET SOUTH & 1310 FEET WEST FROM THE NE CORNER OF SECTION 26.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, is limited to a diversion of ONE-EIGHTIETH of one cubic foot per second, or its equivalent for each acre irrigated, and shall be limited to a diversion of not to exceed 3.0 acre-feet per acre for each acre irrigated during the irrigation season of each year.

The use shall conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use to which this right is appurtenant is as follows:

NW $\frac{1}{4}$ NE $\frac{1}{4}$ 2.1 acres
SW $\frac{1}{4}$ NE $\frac{1}{4}$ 0.4 acre
SE $\frac{1}{4}$ NW $\frac{1}{4}$ 5.5 acres
NE $\frac{1}{4}$ SW $\frac{1}{4}$ 1.0 acre
Section 26
Township 15 South, Range 10 East, W.M.

The right to use water for the above purpose is restricted to beneficial use on the lands or place of use described.


The well shall be maintained in accordance with the General Standards for the Construction and Maintenance of Water Wells in Oregon.

This certificate describes that portion of the water right confirmed by Certificate 65925, State Record of Water Right Certificates, NOT modified by the provisions of an order of the Director entered on DEC 29 1997, 1997, and recorded in Special Order Volume 51, Page 1408, approving a petition by Squaw Creek Irrigation District under ORS 541.325 to 541.333 for mapping water rights within a district.

The issuance of this superseding certificate does not confirm the status of the water right in reference to ORS 540.610 pertaining to forfeiture or abandonment.
