CERTIFICATE OF WATER RIGHT

THIS CERTIFICATE ISSUED TO

SUCCESSORS TO
SQUAW CREEK IRRIGATION COMPANY

confirms the right to use the waters of SQUAW CREEK, a tributary of THE DESCHUTES RIVER, for IRRIGATING 144.0 ACRES AND DOMESTIC USE.

This right was confirmed by decree of the Circuit Court of the State of Oregon for CROOK County. The decree is of record at Salem, in the Order Record of the WATER RESOURCES DIRECTOR, in Volume 1, at Page 120. The date of priority is NOVEMBER, 1904.

The amount of water to which this right is entitled is limited to an amount actually beneficially used and shall not exceed 2.88 CUBIC FEET PER SECOND or its equivalent in case of rotation, measured at the point of diversion from the source.

The point of diversion is located as follows:

(Plainview Ditch) - SW $\frac{1}{4}$ SE $\frac{1}{4}$, Section 28, T. 15 S., R. 10 E., W.M.; 710 feet North and 2640 feet West from the Southwest Corner of Section 28.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, is limited to ONE-FIFTIETH of one cubic foot per second per acre, or its equivalent for each acre irrigated during the irrigation season of each year.

A description of the place of use to which this right is appurtenant is as follows:



This certificate describes that portion of the water right confirmed by Certificate 302, State Record of Water Right Certificates, NOT modified by the provisions of an order of the Director entered on ~~DEC 29 1997~~ 1997, and recorded in Special Order Volume 51, Page ~~1406~~, approving a petition by Squaw Creek Irrigation District under ORS 541.325 to 541.333 for mapping water rights within a district.

The issuance of this superseding certificate does not confirm the status of the water right in regard to the provisions of ORS 540.610 pertaining to forfeiture or abandonment.

The right to the use of the water for the above purpose is restricted to beneficial use on the lands or place of use described and is subject to all other conditions and limitations contained in said decree.
