## CERTIFICATE OF WATER RIGHT

THIS CERTIFICATE ISSUED TO

LYNN E. AND ROSE M. CANNON 886 N DEAN STREET COQUILLE, OR 97423

confirms the right to use the waters of A SPRING, AN UNNAMED STREAM, AND DAVIS CREEK, a tributaries of CROFT LAKE, for DOMESTIC USE FOR ONE FAMILY AND IRRIGATION OF 19.7 ACRES.

This right was perfected under Permit 42573. The date of priority is MARCH 30, 1977. The amount of water to which this right is entitled is limited to an amount actually beneficially used and shall not exceed 0.245 CUBIC FOOT PER SECOND; BEING 0.005 CFS FROM THE SPRING FOR DOMESTIC USE, 0.14 CFS FROM THE UNNAMED STREAM, AND 0.10 CFS FROM DAVIS CREEK FOR IRRIGATION, or its equivalent in case of rotation, measured at the point of diversion from the source.

The points of diversions are located as follows:

SPRING: SW 1/4 NE 1/4, SECTION 13, T 30 S, R 15 W, W.M.; 110 FEET NORTH AND 2160 FEET WEST FROM THE E 1/4 CORNER OF SECTION 13.

UNNAMED STREAM: NW 1/4 SE 1/4, SECTION 13, T 30 S, R 15 W, W.M.; 320 FEET SOUTH AND 1970 FEET WEST FROM THE E 1/4 CORNER OF SECTION 13.

DAVIS CREEK NO. 1: NW 1/4 SE 1/4, SECTION 13, T 30 S, R 15 W, W.M.; 200 FEET SOUTH AND 2500 FEET WEST FROM THE E 1/4 CORNER OF SECTION 13.

DAVIS CREEK NO. 2: NW 1/4 SE 1/4, SECTION 13, T 30 S, R 15 W, W.M.; 640 FEET SOUTH AND 1960 FEET WEST FROM THE E 1/4 CORNER OF SECTION 13.

DAVIS CREEK NO. 3: SE 1/4 SE 1/4, SECTION 13, T 30 S, R 15 W, W.M.; 1300 FEET SOUTH AND 1400 FEET WEST FROM THE E 1/4 CORNER OF SECTION 13.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, is limited to ONE-EIGHTIETH of one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed 2.5 acrefeet per acre for each acre irrigated during the irrigation season of each year.

The use shall conform to such reasonable rotation system as may be ordered by the proper state officer.
