CERTIFICATE OF WATER RIGHT

THIS CERTIFICATE ISSUED TO

confirms the right to use the waters of A WELL in the ROGUE RIVER BASIN, for the purpose of IRRIGATING 8.0 ACRES.

The right has been perfected under Permit G-6827. The date of priority is FEBRUARY 27, 1973. The amount of water to which this right is entitled is limited to an amount actually beneficially used and shall not exceed 0.10 CUBIC FOOT PER SECOND or its equivalent in case of rotation, measured at the point of diversion from the source.

The point of diversion is located as follows:

NE 1/4 SE 1/4, SECTION 16, T 38 S, R 1 W, W.M.; 245 FEET SOUTH AND 590 FEET WEST FROM THE EAST 1/4 CORNER OF SECTION 16.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to ONE-EIGHTIETH of one cubic foot per second per acre, or its equivalent for each acre irrigated during the irrigation season of each year.

The right shall conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use under the right, and to which such right is appurtenant, is as follows:

SW 1/4 NW 1/4 0.1 ACRE
NW 1/4 SW 1/4 1.0 ACRE
SECTION 15

SE 1/4 NE 1/4 0.9 ACRE
NE 1/4 SE 1/4 6.0 ACRES

SECTION 16 TOWNSHIP 38 SOUTH, RANGE 1 WEST, W.M.

When in the judgment of the Watermaster it becomes necessary to install headgates and measuring devices:

the diversion works shall include an in-line flow meter, a weir, or other suitable device for measuring the water to which the wateruser is entitled;

the type and plans of the measuring device be approved by the Watermaster before the beginning of construction work and that the weir or measuring device be installed under the general supervision of said Watermaster.

This certificate is issued to confirm a CHANGE IN USE approved by an order of the Water Resources Director entered SEPTEMBER 12, 1984, and supersedes Permit G-6827, State Record of Water Right Permits.
