## CERTIFICATE OF WATER RIGHT

THIS CERTIFICATE ISSUED TO THE

SUCCESSORS IN INTEREST TO M.S. CORRIGAL

confirms the right to use the waters of BUTTER CREEK AND SPRINGS, TRIBUTARIES OF THE UMATILLA RIVER in the UMATILLA BASIN for IRRIGATION OF 159.7 ACRES OF LAND, DOMESTIC, AND STOCK USE.

The right has been confirmed by decree of the Circuit Court of the State of Oregon for Morrow and Umatilla Counties. The decree is of record at Salem, in the Order Record of the Water Resources Director, in Volume 15, Page 527 as evidenced by the certificate recorded at page 22981, Volume 16, State Record of Water Right Certificates. The dates of priority are 1884 FOR 1.33 CUBIC FEET PER SECOND; 1895 FOR 1.17 CUBIC FEET PER SECOND; AND 1904 FOR 0.73 CUBIC FOOT PER SECOND.

The amount of water to which this right is entitled is limited to an amount actually beneficially used and shall not exceed 3.23 CUBIC FEET PER SECOND or its equivalent in case of rotation.

The points of diversion are located as follows:

SW¼ NW¼, SECTION 27; SE¼ NE¼, SW¼ SE¼, SECTION 28; SW¼ NW¼, SECTION 34; TOWNSHIP 2 NORTH, RANGE 27 EAST, W.M.; SE¼ NE¼, SECTION 25, SE¼ SW¼, SECTION 34; TOWNSHIP 3 NORTH, RANGE 27 EAST, W.M.; POD 1 - 340 FEET NORTH AND 170 FEET EAST FROM THE W¼ CORNER OF SECTION 27; POD 2 - 20 FEET NORTH AND 40 FEET WEST FROM THE W¼ CORNER OF SECTION 27; POD 3 - 200 FEET NORTH AND 1340 FEET WEST FROM THE SOUTHEAST CORNER OF SECTION 28; POD 4 - 250 FEET NORTH AND 380 FEET EAST FROM THE W¼ CORNER OF SECTION 34; POD 5 - 2350 FEET SOUTH AND 840 FEET WEST FROM THE NORTHEAST CORNER OF SECTION 25.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, is limited to a diversion of ONE-FIFTIETH of one cubic foot per second or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed 4.0 ACRE-FEET per acre for each acre irrigated during the irrigation season of each year.

The use shall conform to such reasonable rotation system as may be ordered by the proper state officer.

This use may be regulated if analysis of data available discloses that the appropriation will measurably reduce the surface water flows necessary to maintain the free-flowing character of a scenic waterway in quantities necessary for recreation, fish and wildlife in effect as of the priority date of this right or as those quantities may be subsequently reduced.

This certificate describes that portion of the water right confirmed by Certificate 22981, State Record of Water Right Certificates, NOT modified by the provisions of an order of the Water Resources Director entered January 29, 1987, approving Transfer Application 5851 and an order correcting Transfer 5851.

The issuance of this superseding certificate does not confirm the status of the water right in regard to the provisions of ORS 540.610 pertaining to forfeiture or abandonment.

The right to the use of the water for the above purpose is restricted to beneficial use on the lands or place of use described. The use confirmed herein may be made only at times when sufficient water is available to satisfy all prior rights, including rights for maintaining instream flows.
