CERTIFICATE OF WATER RIGHT

THIS CERTIFICATE ISSUED TO

MARC AND PAMELA THALACKER
70625 NW LOWER BRIDGE WAY
TERREBONNE, OR 97760

confirms the right to use the waters of WELL #9 in the DESCHUTES BASIN for SUPPLEMENTAL IRRIGATION OF 86.0 ACRES.

This right was perfected under Permit G-4396. The date of priority is APRIL 15, 1969. The amount of water to which this right is entitled is limited to an amount actually beneficially used and shall not exceed 1.08 CUBIC FEET PER SECOND or its equivalent in case of rotation, measured at the well.

The well is located as follows:

SW $\frac{1}{4}$ NW $\frac{1}{4}$, SECTION 17, T. 14 S., R. 12 E., W.M.; 20 FEET SOUTH AND 980 FEET WEST FROM THE NW CORNER OF THE SW $\frac{1}{4}$ NW $\frac{1}{4}$, SECTION 17.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, is limited to a diversion of ONE-EIGHTIETH of one cubic foot per second, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed 3.0 acre-feet per acre for each acre irrigated during the irrigation season of each year.

The use shall conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use to which this right is appurtenant is as follows:


SW $\frac{1}{4}$ NE $\frac{1}{4}$ 37.0 ACRES
SE $\frac{1}{4}$ NE $\frac{1}{4}$ 32.5 ACRES
NW $\frac{1}{4}$ SE $\frac{1}{4}$ 16.5 ACRES
Section 18
Township 14 South, Range 12 East, W.M.

The well shall be maintained in accordance with the General Standards for the Construction and Maintenance of Water Wells in Oregon.

This certificate is issued to confirm a change place of use approved by an order of the Water Resources Director entered November 27, 1979, in Transfer Special Order Volume 32, Page 525, as modified by an order entered DEC 29 1997, in Special Order Volume 51, Page 1408, approving the Squaw Creek Irrigation District petition for water rights mapping under ORS 541.325 to 541.333 and together with Certificate 74150 supersedes Certificate 49161.

The right to the use of the water for the above purpose is restricted to beneficial use on the lands or place of use described.
