CERTIFICATE OF WATER RIGHT

THIS CERTIFICATE ISSUED TO

JOSEPH O. RUDI PO BOX 425 BAKER CITY, OR 97814

confirms the right to use the waters of NELSON SPRING, a tributary of SALMON CREEK, for PRIMARY IRRIGATION OF 21.4 ACRES AND THE SUPPLEMENTAL IRRIGATION OF 197.2 ACRES.

This right was perfected under Permit 43376. The date of priority is MAY 24, 1978. The amount of water to which this right is entitled is limited to an amount actually beneficially used and shall not exceed 3.0 CUBIC FEET PER SECOND, or its equivalent in case of rotation, measured at the point of diversion from the source.

The point of diversion is located as follows:

NE 1/4 SW 1/4, SECTION 5, T 9 S, R 39 E, W.M.; 850 FEET SOUTH AND 440 FEET WEST FROM THE C 1/4 CORNER OF SECTION 5.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, is limited to ONE-FORTIETH of one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed 3.5 acrefeet per acre for each acre irrigated during the irrigation season of each year.

The use shall conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use to which this right is appurtenant is as follows:
