CERTIFICATE OF WATER RIGHT

THIS CERTIFICATE ISSUED TO

JOHN HARRY JACOBSON 7130 SMULLEN ROAD MT. HOOD, OREGON 97041

confirms the right to use the waters of YELLOW JACKET CREEK, EAST FORK HOOD RIVER AND RESERVOIR 1, tributaries of HOOD RIVER, for IRRIGATION OF 18.3 ACRES.

This right was perfected under Permit 47448. The date of priority is JULY 12, 1982. The amount of water to which this right is entitled is limited to an amount actually beneficially used and shall not exceed 0.228 CUBIC FOOT PER SECOND, FROM YELLOW JACKET CREEK WITH ANY DEFICIENCY TO BE SUPPLIED BY EAST FORK HOOD RIVER AND RESERVOIR 1, or its equivalent in case of rotation, measured at the point of diversion from the source.

The points of diversion are located as follows:

POD 1 (YELLOW JACKET CREEK) - SW 1/4 NE 1/4; POD 2 (RESERVOIR 1) - NE 1/4 NW 1/4; AND POD 3 (EAST FORK HOOD RIVER) - NW 1/4 NW 1/4, ALL IN SECTION 9; POD 4 (EAST FORK HOOD RIVER) - NW 1/4 SW 1/4, SECTION 4, ALL WITHIN T 1 S, R 10 E, W.M.; BEING (POD 1) - 780 FEET NORTH AND 1865 FEET WEST FROM THE E 1/4 CORNER OF SECTION 9; (POD 2) - 450 FEET SOUTH AND 850 FEET WEST FROM THE NORTH 1/4 CORNER OF SECTION 9; (POD 3) - 165 FEET SOUTH AND 455 FEET EAST FROM THE NORTHWEST CORNER OF SECTION 9; (POD 4) - 1020 FEET SOUTH AND 2140 FEET WEST FROM THE CENTER CORNER OF SECTION 4.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, is limited to ONE-EIGHTIETH of one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed 3.0 acrefeet per acre for each acre irrigated during the irrigation season of each year.

The use shall conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use to which this right is appurtenant is as follows:

NW 1/4 SE 1/4 10.4 ACRES SW 1/4 SW 1/4 0.8 ACRE SE 1/4 SW 1/4 7.1 ACRES SECTION 4 TOWNSHIP 1 SOUTH, RANGE 10 EAST, W.M.

The right to the use of the water for the above purpose is restricted to beneficial use on the lands or place of use described. The use confirmed herein may be made only at times when sufficient water is available to satisfy all prior rights, including rights for maintaining instream flows.
