PROPOSED CERTIFICATE OF WATER RIGHT

THIS CERTIFICATE ISSUED TO

MIDDLE FORK IRRIGATION DISTRICT P.O. BOX 291 PARKDALE, OREGON 97041

confirms the right to use the waters of ROGER CREEK, a tributary of MIDDLE FORK OF HOOD RIVER, for IRRIGATION OF 123.0 ACRES.

This right was perfected under Permit E-29. The date of priority is JANUARY 19, 1910. The amount of water to which this right is entitled is limited to an amount actually beneficially used and shall not exceed 1.54 CUBIC FEET PER SECOND or its equivalent in case of rotation, measured at the point of diversion from the source.

The point of diversion is located as follows:

 NW^1_4 OF SE 1_4 , SECTION 31, T. 1 N., R. 10 E., W.M., BEING 1520 FEET NORTH AND 3870 FEET EAST FROM THE SW CORNER SECTION 31.

The amount of water used for irrigation together with the amount secured under any other right existing for the same lands, is limited to ONE-EIGHTIETH of one cubic foot per second per acre or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed 3 acre-feet for each acre irrigated during the irrigation season of each year.

The use shall conform to such reasonable rotation system ordered by the proper state officer.
