PROPOSED CERTIFICATE OF WATER RIGHT

THIS CERTIFICATE ISSUED TO

MIDDLE FORK IRRIGATION DISTRICT P.O. BOX 291 PARKDALE, OREGON 97041

confirms the right to use the waters of CLEAR CREEK AND ELIOT CREEK, a tributary of MIDDLE FORK HOOD RIVER, for IRRIGATION OF 4.4 ACRES.

This right was perfected under Permit 36065. The date of priority is APRIL 9, 1971. The amount of water to which this right is entitled is limited to an amount actually beneficially used and shall not exceed .06 CUBIC FOOT PER SECOND BEING 0.05 CUBIC FOOT PER SECOND FROM CLEAR CREEK AND 0.01 CUBIC FOOT PER SECOND FROM ELIOT CREEK or its equivalent in case of rotation, measured at the point of diversion from the source.

The point of diversion is located as follows:

NW 1/4 OF NE 1/4, SECTION 27, SW 1/4 OF NE 1/4, SECTION 26, T. 1 S., R. 9 E., W.M. CLEAR CREEK - 520 FEET SOUTH AND 2500 FEET WEST FROM NE CORNER, SECTION 27, ELIOT CREEK - 2450 FEET SOUTH AND 2280 FEET WEST FROM NE CORNER, SECTION 26, SW 1/4 OF SE 1/4, SECTION 19, T. 1 S., R. 10 E., W.M.; PUMP - 1180 FEET NORTH AND 1100 FEET EAST FROM THE S 1/4 CORNER, SECTION 19.

The amount of water used for irrigation together with the amount secured under any other right existing for the same lands, is limited to ONE-EIGHTIETH of one cubic foot per second per acre or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed 3 acre-feet for each acre irrigated during the irrigation season of each year.

The use shall conform to such reasonable rotation system ordered by the proper state officer.

A description of the place of use to which this right is appurtenant is as follows:
