PROPOSED CERTIFICATE OF WATER RIGHT

THIS CERTIFICATE ISSUED TO

THOMAS AND BARBARA PURDIE  
8000 JORDON ROAD  
PARKDALE, OREGON 97041

confirms the right to use the waters of GRISWELL CREEK, a tributary of EAST FORK HOOD RIVER, for IRRIGATION OF 9.5 ACRES AND STOCK WATER.

This right was confirmed by decree of the Circuit Court of the State of Oregon for HOOD RIVER County. The decree is of record at Salem, in the Order Record of the WATER RESOURCES DIRECTOR, in Volume 6, at Page 237. The date of priority is 1899.

The amount of water to which this right is entitled is limited to an amount actually beneficially used and shall not exceed 0.119 CUBIC FOOT PER SECOND or its equivalent in case of rotation, measured at the point of diversion from the source.

The point of diversion is located as follows:

SE 1/4 OF NE 1/4, SECTION 8, T. 1 S., R. 10 E., W.M., BEING 880 FEET SOUTH AND 620 FEET WEST FROM EAST 1/4 CORNER, SECTION 8.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, is limited to ONE-EIGHTIETH of one cubic foot per second per acre or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed 3 acre-feet for each acre irrigated during the irrigation season of each year.

The use shall conform to any reasonable rotation system ordered by the proper state officer.

A description of the place of use to which this right is appurtenant is as follows:

9.5 ACRES AND STOCK WATER  
NW 1/4 OF SE 1/4  
SECTION 5  
T. 1 S., R. 10 E., W.M.

The right to the use of the water for the above purpose is restricted to beneficial use on the lands or place of use described and is subject to all other conditions and limitations contained in said decree.

This certificate is issued to confirm a change in POINT OF DIVERSION approved by an order of the Water Resources Director entered Sept. 5, 1978 and recorded in Volume 31, Page 177. This certificate also describes that portion of the water right not canceled by an order of the Water Resources Director entered June 9, 1976, and recorded in Volume 26, Page 177. This certificate supersedes certificate 14959, State Record of Water Right Certificates.

The issuance of this superseding certificate does not confirm the status of the water right in regard to the provisions of ORS 540.610 pertaining to forfeiture or abandonment.
