CERTIFICATE OF WATER RIGHT

THIS CERTIFICATE ISSUED TO

confirms the right to use the waters of two wells, a tributary of the Cow Creek, for the irrigation of 491.7 acres.

This right was perfected under Permit G-3319. The date of priority is August 3, 1966. The use is limited to 6.15 CUBIC FEET PER SECOND (CFS), BEING 2.93 CFS FROM WELL NO. 1 AND 3.22 CFS FROM WELL NO 2 or its equivalent in case of rotation, measured at the point of diversion from the source.

The wells are located as follows:

Well No. 1 - Lot 1 (NE1/4 SW1/4), Section 32, Township 30 South, Range 8 East, WM;
Well No. 2 - Lot 4 (NW1/4NW1/4), Section 6, Township 31 South, Range 8 East, WM; Well
No. 1 - 1980 feet North and 4990 feet East; Well No. 2 - 670 feet South, both from the S 1/4
Corner Section 31, Township 30 South, Range 8 East, WM.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, is limited to a diversion of ONE-EIGHTIETH of one cubic foot per second or its equivalent for each acre irrigated from direct flow and shall be further limited to a diversion of not to exceed 3.0 acre feet per acre for each acre irrigated during the irrigation season of each year, and shall conform to such reasonable rotation system as may be ordered by the proper state officer.

The right to the use of the water for the above purpose aforesaid is restricted to the lands or place of use herein described, and is subject to the existing minimum flow policies established by the Water Policy Review Board.
