CERTIFICATE OF WATER RIGHT

THIS CERTIFICATE ISSUED TO

ROBERT L. LOGAN WILLIAM L. SCHERBARTH 34501 AGNESS-ILLAHE ROAD AGNESS, OREGON 97406

confirms the right to use the waters of A SPRING, A TRIBUTARY OF THE ROGUE RIVER AND THE ROGUE RIVER, a tributary of THE PACIFIC OCEAN, for DOMESTIC USE FOR ONE FAMILY, COMMERCIAL USE, AND IRRIGATION OF 4.6 ACRES.

This right was perfected under Permit 44236. The date of priority is MARCH 19, 1979. The amount of water to which this right is entitled is limited to an amount actually beneficially used and shall not exceed 0.068 CUBIC FOOT PER SECOND, BEING 0.005 CFS FOR DOMESTIC USE AND 0.003 CFS FOR COMMERCIAL USE FROM THE SPRING AND 0.06 CFS FROM THE RIVER FOR IRRIGATION, or its equivalent in case of rotation, measured at the point of diversion from the source.

The points of diversion are located as follows:

LOT 6 (SE 1/4 SW 1/4), SECTION 7, T 35 S, R 11 W, W.M.; SPRING - 1100 FEET NORTH AND 1900 FEET EAST; RIVER - 1200 FEET NORTH AND 2150 FEET EAST, BOTH FROM THE SOUTHWEST CORNER OF SECTION 7.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, is limited to ONE-EIGHTIETH of one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed 4.5 acre-feet per acre for each acre irrigated during the irrigation season of each year.

The use shall conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use to which this right is appurtenant is as follows:

LOT 7 (NE 1/4 SW 1/4) 2.6 ACRES DOMESTIC COMMERCIAL SECTION 7

TOWNSHIP 35 SOUTH, RANGE 11 WEST, W.M.

The right to the use of the water for the above purpose is restricted to beneficial use on the lands or place of use described. The use confirmed herein may be made only at times when sufficient water is available to satisfy all prior rights, including rights for maintaining instream flows.
