CERTIFICATE OF WATER RIGHT

THIS CERTIFICATE ISSUED TO

JIM YOUNG
13291 HIGHWAY 238
JACKSONVILLE, OR 97530

confirms the right to use the waters of the APPLGATE RIVER, a tributary of the ROGUE RIVER, for IRRIGATING 3.4 ACRES.

This right was confirmed by decree of the Circuit Court of the State of Oregon for JACKSON COUNTY. The decree is of record at Salem, in the Order Record of the WATER RESOURCES DIRECTOR, in Volume 4, at Page 23. The date of priority is 1866.

The amount of water to which this right is entitled is limited to an amount actually beneficially used and shall not exceed 0.09 CUBIC FOOT PER SECOND, or its equivalent in case of rotation, measured at the point of diversion from the source.

The point of diversion is located as follows:

SW 1/4 NE 1/4, SECTION 26, T 38 S, R 4 W, W.M.; 1400 FEET SOUTH AND 2230 FEET WEST FROM THE NE CORNER SECTION 26.

The quantity of water diverted at the new point of diversion, shall not exceed the quantity of water available at the old point of diversion under the subject right, and shall not exceed 0.09 cubic foot per second.

A description of the place of use to which this right is appurtenant is as follows:

NW 1/4 NE 1/4 3.4 ACRES
SECTION 26
TOWNSHIP 38 SOUTH, RANGE 4 WEST, W.M.

This certificate is issued to confirm a change in PLACE OF USE AND POINT OF DIVERSION approved by an order of the Water Resources Director entered JUNE 17, 1987, and together with Certificate 56493, supersedes Certificate 52773, State Record of Water Right Certificates.

The issuance of this superseding certificate does not confirm the status of the water right in regard to the provisions of ORS 540.610 pertaining to forfeiture or abandonment.

When in the judgment of the Watermaster it becomes necessary to install headgates and measuring devices:

the diversion works shall include an in-line flow meter, a weir, or other suitable device for measuring the water to which the wateruser is entitled;

the type and plans of the measuring device be approved by the Watermaster before the beginning of construction work and that the weir or measuring device be installed under the general supervision of said Watermaster.

The right to the use of the water for the above purpose is restricted to beneficial use on the lands or place of use described and is subject to all other conditions and limitations contained in said decree.
