## CERTIFICATE OF WATER RIGHT

THIS CERTIFICATE ISSUED TO

ESTATE OF KENNETH O. LAIRD C/O MARTIN E. STONE PO BOX 158 COQUILLE, OREGON 97423

confirms the right to use the waters of A WELL in the SILVER CREEK BASIN for IRRIGATION OF 59.8 ACRES.

This right was perfected under Permit G-1241. The date of priority is FEBRUARY 6, 1959. The amount of water to which this right is entitled is limited to an amount actually beneficially used and shall not exceed 0.57 CUBIC FOOT PER SECOND, or its equivalent in case of rotation, measured at the point of diversion from the source.

The well is located as follows:

LOT 3 (NE 1/4 NW 1/4), SECTION 2, T 27 S, R 15 E, W.M.; 1342 FEET SOUTH AND 2646 FEET WEST FROM THE NE CORNER OF SECTION 2.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, is limited to ONE-EIGHTIETH of one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed 3.0 acre-feet per acre for each acre irrigated during the irrigation season of each year.

The use shall conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use to which this right is appurtenant is as follows:

LOT 3 (NE 1/4 NW 1/4) 40.0 ACRES SE 1/4 NW 1/4 19.8 ACRES SECTION 2
TOWNSHIP 27 SOUTH, RANGE 15 EAST, W.M.

The well shall be maintained in accordance with the General Standards for the Construction and Maintenance of Water Wells in Oregon.

THIS CERTIFICATE IS ISSUED TO CORRECTLY DESCRIBE THE PLACE OF USE AND SUPERSEDES CERTIFICATE 72466.

This certificate is issued to confirm a change in POINT OF APPROPRIATION approved by an order of the Water Resources Director entered NOVEMBER 24, 1989, and supersedes Certificate 31370, State Record of Water Right Certificates.

The issuance of this superseding certificate does not confirm the status of the water right in regard to the provisions of ORS 540.610 pertaining to forfeiture or abandonment.

The right to use water for the above purpose is restricted to beneficial use on the lands or place of use described.
