## CERTIFICATE OF WATER RIGHT

THIS CERTIFICATE ISSUED TO

FARMERS IRRIGATION DISTRICT 1985 COUNTRY CLUB ROAD HOOD RIVER, OREGON 97031

confirms the right to use the waters of HOOD RIVER, a tributary of COLUMBIA RIVER, for IRRIGATION OF 15.4 ACRES.

This right was confirmed by decree of the Circuit Court of the State of Oregon for HOOD RIVER County. The decree is of record at Salem, in the Order Record of the WATER RESOURCES DIRECTOR, in Volume 17, at Page 333. The date of priority is MAY 7, 1906.

The amount of water to which this right is entitled is limited to an amount actually beneficially used and shall not exceed 0.19 CUBIC FOOT PER SECOND or its equivalent in case of rotation, measured at the point of diversion from the source.

The point of diversion is located as follows:

NW 1/4 OF SW 1/4, SECTION 31, T. 2 N., R. 10 E., W.M., BEING 2250 FEET NORTH AND 470 FEET EAST FROM THE SW CORNER, OF SECTION 31.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, is limited to ONE-EIGHTIETH of one cubic foot per second per acre or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed 3 acre-feet for each acre irrigated during the irrigation season of each year.

The use shall conform to any reasonable rotation system ordered by the proper state officer.
