## CERTIFICATE OF WATER RIGHT

THIS CERTIFICATE ISSUED TO

IRV JOHNSON TRUSTEE 1020 RAND ROAD HOOD RIVER, OREGON 97031

CHARLES AND BARBARA BEARDSLEY 2800 EUGENE STREET HOOD RIVER, OREGON 97031

confirms the right to use the waters of WASTE WATER FROM NEIGHBORING LAND, a tributary of COLUMBIA RIVER, for IRRIGATION OF 5.65 ACRES AND SUPPLEMENTAL IRRIGATION OF 6.1 ACRES.

This right was perfected under Permit 7447. The date of priority is JULY 16, 1926. The amount of water to which this right is entitled is limited to an amount actually beneficially used and shall not exceed 0.15 CUBIC FOOT PER SECOND or its equivalent in case of rotation, measured at the point of diversion from the source.

The point of diversion is located as follows:

NW 1/4 NW 1/4, SECTION 35, SW 1/4 SW 1/4, SECTION 26, T. 3 N., R. 10 E. W. M., BEING #1 ABOUT 26 RODS SOUTH AND 80 ROADS EAST, #2 ABOUT 42 RODS SOUTH AND 80 RODS EAST, BOTH FROM THE NW CORNER SECTION 35.

The amount of water used for irrigation together with the amount secured under any other right existing for the same lands, is limited to ONE-EIGHTIETH of one cubic foot per second per acre or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed 3 acre-feet for each acre irrigated during the irrigation season of each year.

The use shall conform to such reasonable rotation system ordered by the proper state officer.

A description of the place of use to which this right is appurtenant is as follows:

- 3.85 ACRES SW 1/4 SW 1/4 SECTION 26
- 1.8 ACRES NW 1/4 NW 1/4 SECTION 35
- T. 3 N., R. 10 E., W. M.

## SUPPLEMENTAL IRRIGATION

- 0.90 ACRES (JOHNSON) SW 1/4 SW 1/4 SECTION 26
- 5.2 ACRES (BEARDSLEY) NW 1/4 NW 1/4 SECTION 35

The right to the use of the water for the above purpose is restricted to beneficial use on the lands or place of use described and is subject to all other conditions and limitations contained in said permit.

This certificate confirms an order of the Director entered on JUN 1997, 1997 and recorded in Special Order Volume 51, page 360, approving a petition by FARMERS IRRIGATION DISTRICT under ORS 541.329 for mapping water rights within a district. This certificate supersedes certificate 7522.

The issuance of this superseding certificate does not confirm the status of the water right in regard to the provisions of ORS 540.610 pertaining to forfeiture or abandonment.
