CERTIFICATE OF WATER RIGHT

THIS CERTIFICATE ISSUED TO

GEORGE DES BRISAY CANBY, OREGON 97013

confirms the right to use the waters of the MOLALLA RIVER, a tributary of the WILLAMETTE RIVER, for IRRIGATION OF 93.0 ACRES.

This right was perfected under Permit 21320. The date of priority is APRIL 16, 1952. The amount of water to which this right is entitled is limited to an amount actually beneficially used and shall not exceed 1.16 CUBIC FOOT PER SECOND or its equivalent in case of rotation, measured at the point of diversion from the source.

The point of diversion is located as follows:

LOT 7 (NW% SE%), SECTION 20; NE% NW%, SECTION 29, T 3 S, R 1 E, WM; 4200 FEET NORTH AND 2610 FEET WEST; 1450 FEET NORTH AND 3160 FEET WEST, BOTH FROM THE E% CORNER, SECTION 29.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, is limited to ONE-EIGHTIETH of one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed 2% acre-feet for each acre irrigated during the irrigation season of each year.

The use shall conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use to which this right is appurtenant is as follows:
